Thank you for your interest in Manzanita Charter School. We are a public parent cooperative charter school serving students in the 6th, 7th and 8th Grades. Application

Please complete the attached application packet and bring or mail it to the school office with:

- a copy of a PG&E bill showing the residence address, and
- a copy of the student's immunization record, and
- a copy of your Tuberculosis Clearance (TB Test) if you plan to donate volunteer hours.

Priority Volunteer Hours

If you choose, you may donate volunteer hours to the school once you have turned in an application. These hours can give your application a higher priority (as defined below), however *they are not a guarantee of acceptance*.* Priority volunteer hours can be completed on campus weekdays between 8:00 am and 4:00 pm and during work parties scheduled once each semester.

Admission priority is given in the following order:

Returning Students

Returning students in good standing are given first priority. This applies only to 7th and 8th grades. (Good standing means the family is current with its commitment to complete 8 hours per month, 2 cleanings per year, and to attend 10 membership meetings per year.)

Siblings

Siblings of returning students in good standing and alumni who recently left the school in good standing are next. If you fall into this category, please speak with Colleen, Tara or Angela before completing any hours.

Level I*

Level I* families are next. A Level I family is defined as a family who has contributed a minimum of 50 hours of work to the school before March 31, 2010, *with at least 10 of these hours completed between January 1, 2010 and March 31, 2010*. The family can live within or outside of the West Contra Costa Unified School District (WCCUSD).

Level II

Level II families are next. A Level II family is defined as a family who lives within the WCCUSD and who has contributed 10 hours of work to the school by March 31, 2010.

In-District

Families that reside within the WCCUSD and who have not contributed hours are next.

Out of District

Families who reside outside the WCCUSD and who have not contributed hours are last.

In the event that we have more applicants than spaces available after applying the foregoing admission priorities, a public random drawing will take place within each priority category that has exceeded the spaces available. Any applications received after the application deadline will be added to the end of the waitlist in the order received. *For further information about the Manzanita admission process, including the legal charter language, please review Element 8 of the Manzanita Charter, available at www.manzy.org.*

Information Events

Before submitting a school application, interested families are encouraged to attend an information event with school representatives to ensure an understanding of the Manzanita cooperative school program and the family's obligations to the school.

I agree to be an active participant in my child's education and in the Manzanita Charter School community. To that end I agree to the following:

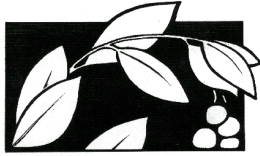

- I will see that my student attends regularly, arrives at school on time and is picked up / goes home at the school dismissal time. I understand that there is no after school care.
- I will attend parent conferences as scheduled by the teachers, who will work to provide flexibility in the conference schedule.

MANZANITA VOLUNTEER REQUIREMENTS

WHO: All Manzanita Charter School Parents & Volunteers

WHAT: Tuberculosis (TB) Skin Test

WHERE: Facilities Listed Below

Dear Manzanita Parents,

In an effort to keep our students at Manzanita in a healthy and safe environment, we are requiring that all parents and family members volunteering submit **tuberculosis clearance** before any volunteer hours are done.

If you have taken this test and it is no older than 1 year, you can bring proof of test to the school office. The West Contra Costa Unified School District (WCCUSD) requires TB/PPD test to be current every 4 years. Upon receiving clearance from your doctor or receiving a negative test, please turn in or mail your clearance to the school office.

We are providing a list of facilities that offer the intra-dermal skin test. Please take advantage and have this test taken care of over the summer break. This way you and your family members can begin volunteer hours at the start of the new school year.

In addition, parents and volunteers who will be working with students without the supervision of Manzanita staff or participating in special activities will be required to also submit **fingerprint clearance**. If you fall into this category, you will be notified personally. Fingerprinting can be done in the Human Resources office at WCCUSD -153 12th St Richmond, CA 94801, (510) 231-1185. The cost is \$32 per person. As allowed by the school's budget, the school will reimburse the parent/volunteer for the cost of the fingerprinting.
